RECOMMENDED USAGE LEVELS

20 TO 150 PPM BASED ON THE WEIGHT OF THE SYSTEM. THE PRODUCT MAY BE METERED ON A CONTINOUS BASIS OR ADDED ON A BATCH PROCESS. PRODUCT SHOULD BE ADDED NEAT – DO NOT DILUTE WITH WATER. AF-606 SHOULD BE ADDED TO THE INFLUENT PRIOR TO AERATION AND/OR DIGESTION OR DIRECTLY TO THE LIQUID SURFACE IN THE DIGESTION PROCESS.
